**NOTICE RE-INVITING TENDERS**


Imphal, the 7<sup>th</sup> December 2011.

In pursuance of the decision taken in the meeting of the Unified Metropolitan Transport Authority (UMTA), Manipur the Principal Secretary(Transport), Govt. of Manipur cum Member Secretary, Unified Metropolitan Transport Authority, Manipur re-invites Bids from registered, reputed and financially sound Transport Societies/Association/Organisation/individuals and other Public Transport Service providers for operation of passenger services & maintenance procedures besides management of man power & inventories including drivers, conductors/helpers/cleaners, time keepers for a period of 7 (seven) years for implementation of operation and maintenance of 10 nos of Semi Low Floor Buses released under the JnNURM Project by the Ministry of Urban Development, Govt. of India in the State of Manipur but within Imphal & Greater Imphal Areas in 5 (five) designated routes under the Public Private Partnership (PPP) model which may be extendable for a specified period of time under certain terms & conditions which shall be described in the Bid Document.

The Service Provides/ Concessionaries having at least three years experience in the field of operation of public service transport in the State besides having valid Registration Certificates from the offices of the Registrar of Society, Manipur/, Labour Commissioner, Govt of Manipur and also having ESI/EPF/PPF, Service Tax and PAN/GIR Nos. from the concerned Department of the Government of the Government for providing the services mentioned above, shall be eligible for participating the Bid. Further, the Bidder should have at least 3 years audited statement of a/c having 10 (Ten) lakhs balance in a scheduled bank duly certified by a registered Charter Accountant.

The RFP/Bid documents for this Contract may be obtained from the Office of the Principal Secretary(Transport) cum Member Secretary, UMTA, Manipur after 14 days (fourteen) days from the date of issue of Bid notification in between 11.30 a.m. to 4.00 p.m. on all working days on all working days on payment of Rs. 10,000/-(Rupees ten thousand only) by Crossed Demand Draft in favour of Principal Secretary(Transport) cum Member Secretary, UMTA, Manipur payable at Imphal. Further, the Bid/REP document may also be downloaded from the official website of the Government of Manipur in which case, a demand draft of Rs.10,000/-(Rupees ten thousand only) will have to be enclosed towards the cost of RFP /Bid documents at the time of submission of Bid.
