
The Request for Proposal (RFP) for Manipur State Data Centre, approved by DIT, Government of India, was issued on 30th January 2010 and published in the Manipur Government Website www.manipur.nic.in. The Short Tender Notice was also published through DIPR, Govt. of Manipur in 3 National dailies and 5 Local dailies. In addition, emails regarding the RFP had also been sent to many of the Firms which had submitted bids for State Data Centre in other States, for maximum publicity.

2. The Pre-Bid conference at Imphal was attended by 3(three) Intending Bidders. Also queries/request for clarifications had been received over email from 3(three) other Intending Bidders.

3. The various queries on RFP for Manipur State Data Centre RFP were broadly discussed. The intending Bidders were informed that the formal/ official clarifications would be published on the Manipur Government website within a few days. A request was made by the intending bidders to make available the Manipur SDC Site Layout Plan and the Electrical Single Line diagram in DWG or similar format.

4. The representatives of the Intending Bidders also visited the 2500 sq.ft. Manipur SDC site on the 4th floor of Western Block, New Secretariat, Imphal, which is in ready condition for handing over to the selected Bidder, once the Bid is finalized.
